Appearance Request: Mr. Scott Koley, Streator, spoke to the Board about his idea to find a location and funding for a skate park. He is looking for support for the idea and is open to any suggestions for possible locations in the surrounding community. Appearance Request: Mr. Doug Ploch, Utica, spoke to the Board about his new electric bike rental business. He is currently located on the City Limits property and he is renting pedal assist bikes by the hour. He is also looking for locations downtown. He is talking to a few of the business owners but nothing is in place yet.

Trustee Pappas asked if credit cards will be used to rent the bikes and Mr. Ploch answered that only cash would be accepted.

Trustee Dave Stewart asked about the liability and Mr. Ploch answered that he has insurance and the businesses that rent out the bikes for him would be listed as an additional insured as well.

He then stated that biking is a great addition to the other outdoor activities in the area. He would also like the towpath opened up by the DNR so that people can ride there as well. The Village recognizes the importance of the I & M Canal and towpath to the community and has reached out to the DNR several times to request help. It is unclear whether he will need a business license or a peddler's license and the Board would still like to see a business plan. He answered that he is still in the planning phase and doesn't plan to expand further until sometime next year.

Engineer's Report: Village Engineer Kevin Heitz provided an update of ongoing projects in the Village. Senica Manor 777<sup>th</sup> road – An estimate was provided outlining the cost associated with running water to properties located on 777<sup>th</sup> road.

Option A = \$33,800 - \$36,400

Option B = \$32,160 - \$34,560

Option C = \$28,980 - \$30,660

The total to do the entire project would be approx. \$94,940 - \$101,620

Trustee Pawlak asked how deep the rock is in that area. Heitz stated that most of the project would probably require boring so the depth of the rock might not be an issue. Mr. Ploch asked about the benefits of annexing his property. Heitz stated that he would have access to Village water.

Also, the properties would be annexed in to the Village and then the road would be the Village's responsibility. Currently the road surface is tar and chip however the Village would probably have to asphalt the road in the future.

The Board decided to review the information and further discuss it at a later date.

Illinois River Bridge – Heitz determined that the sewer discharge pipe located from the river to the sewer plant will need to be replaced. IDOT will include it in their plans once Heitz provides them with the information regarding the length and size.

Mill St. Design – Meetings will need to be held with the Businesses to inform them of the project and schedule. It should be bid out by the middle of January followed by the possible award of a contract at the February 2016 Board meeting. The target to do the project is between the 2016 St. Pat's parade and Memorial Day.

Ameren Gas Line Project – Restoration of areas is still being completed but the project is done.

MFT / Non-MFT Project (Hallet Road) – The estimate for the project is \$261,900. Bids are due on September 17, 2015. The Bids will be reviewed and considered at the September 22, 2015 Special Board Meeting. The project will begin after Burgoo.

Illinois Disaster Relief Fund Grant – No more applications are being taken. The Board is considering doing aerial photos to determine if anything has changed that would impact the flood waters entering the Village. Also, the Board is considering placing a gage on the Clark Creek Bridge that would provide an alert to the Village in the event of rising water.

Public Works Director Spayer stated that he knows someone who does aerial topography photos. He will bring information to the next meeting.

Sidewalk -The sidewalk at the Library will be re-poured by Wozniak concrete once Spayer removes the damaged concrete panels.

Johnson St. Water Main Project - the contractor will rake and re-seed a few areas before the Village will release the final 5% payment on the contract.
