Mr. Mertel is seeking a Variance for the construction of a detached garage on the property.

Attorney Klein swears in Mr. Mertel before Testimony begins.

Mr. Mertel would like to build a 24 X 24 garage in his backyard inside the current privacy fence for the purpose of gaining additional storage. It will consist of a 16 ft. wide garage door and the height of the garage will be 12 ft.

Setbacks were discussed among the group. Mr. Mertel is requesting a Variance for 15 ft. setbacks.

Member Fry asked about the construction materials of the exterior of the garage.

Mr. Mertel answered that it would have siding similar to the siding on the house.

Member Hamilton asked if he will be putting in another driveway.

Mr. Mertel answered that there will be an 8 ft. apron but no driveway.

With no further questions or testimony, it was motioned by Member Fry, seconded by Member Hamilton to close the Public Hearing at 6:48 pm.
