At 7:05 the Board meeting was called or Order by Village President David Stewart who then led the Pledge of Allegiance. Village Clerk Laurie Gbur recorded meeting attendance. Present at the meeting were Trustees Debbie Krizel, Mary Pawlak, Jim Schrader, John Schweickert, Nate Holland and Ron Pawlak. Also present at the meeting were Village Engineer Kevin Heitz, Director of Village Affairs Jamie Turczyn, Public Works Director / Zoning Enforcement Officer Curt Spayer, Police Chief Rodney Damron and Village Treasurer Jill Margis. Attorney Colin Barry attended the meeting in the absence of Village Attorney Herb Klein.

Appearance Request: Ms. Kim Bird, representing Hopkins & Associates, attended the meeting to present the annual Audit for Fiscal Year ending 3-31-2021. She provided copies of the Audit to the Board as well as a brief summary of the revenues, expenditures and fund balances for the fiscal year. It was motioned by Trustee Krizel, seconded by Trustee Schweickert to accept the Village of North Utica Audit for Fiscal Yr ending 3-31-2021 as presented.

Village Attorney: In the absence of Village Attorney Klein, Attorney Barry provided a brief summary regarding the Petition of Paul Williams, as Petitioner and proposed Lessee of property and Owen R. Seibert and Patricia A. Seibert, Owners of property located at 615 S. Clark St., Utica, IL, 61373. The Petitioners are seeking an amendment to the Village of North Utica Zoning Code, adding as a Defined Business in the C-2 Zoning District, the Operation of an Animal Experience Attraction consisting of farm type animals, with temporary and portable enclosures, and for any other amendment to the Code necessary to allow the intended use. The Petitioners are also seeking a Special Use under Section 10-8B-3 to allow the Operation of an Animal Experience Attraction as the intended use on the property located at 615 S. Clark St., Utica, IL 61373.

Attorney Barry stated that the Petitioners, who own and operate Cedar Creek Ranch in Cedar Point, IL, are seeking to operate an Animal Experience Attraction, ie., petting zoo, on the property. The property is located in the flood plain, therefore Mr. Williams indicated that he would like to utilize portable structures for the business at this time. Mr. Williams stated that there would be miniature farm animals, a bounce house, a small ring for pony rides and an information booth. He would bring in his own water tanks and would be managing all waste by utilizing a base of ag-lime rock to reduce odor. All feed and waste removal will be portable. The operation of the business would be 7 days per week from 10 am – 6 pm; weather permitting.

Trustee Schweickert stated that he thought that the business would be a great addition to the Village. Trustee Krizel agreed and stated that this would be a great family friendly experience for people to enjoy in the Village.

Attorney Barry then stated that the first item to consider would be to amend the Zoning Ordinance to define an Animal Experience Attraction as a Special Use in the C-2 Zoning District. Village Engineer: Village Engineer Heitz provided a brief update on the upcoming and ongoing projects in the Village.

2856th Rd. Paved Ditch Repairs – There is a property located on 2856th Rd. that has a paved ditch that goes through a resident's driveway. The pavement surrounding the ditch is in poor shape and needs repairs. The cost to repair the ditch will be approx. \$16,520. It was motioned by Trustee Schweickert, seconded by Trustee R. Pawlak to repair the paved ditch on 2856th Rd. at a cost not to exceed \$16,520.

Engineer Heitz then stated that new curb and sidewalk is needed along Water St. The new Farmers Market is being constructed and the Village will need to install curbing and sidewalk, overlay the road and install new inlets to manage drainage and to offer access along the parking area for the business. The estimated cost for the project is approx. \$56,000. This project will be on a future agenda for Board consideration along with the MFT road project.

Trustee R. Pawlak asked if Northwest St. would be included in the street assessment priority list for the MFT road project. Engineer Heitz stated that Northwest St. would be included and that he will begin the street assessment soon and provide a priority list for Board consideration at a future meeting. He also stated that he would be assessing the township roads to determine whether they will need to be added to the Village's project as well.

Johnson St. Drainage Project – Engineer Heitz and Public Works Director Spayer are still in the process of reviewing the project.

Senica Manor Drainage Project - Engineer Heitz and Public Works Director Spayer are still in the process of speaking to the property owners and reviewing the project.

New Village Administrative Building – Engineer Heitz stated that Director of Village Affairs Jamie Turczyn has been doing a great job meeting with contractors and getting estimates to keep the project moving along. The Board previously approved Gary Hopps Painting to do the painting in the building, however he is no longer available, therefore Jamie met with another contractor, Streator Decorators, to get another estimate. Streator Decorators would be available to do the painting at a cost not to exceed \$25,000. It was motioned by Trustee Holland, seconded by Trustee Schweickert to rescind the previous motion from the June 2021 Board meeting and to approve the estimate from Streator Decorators to do the painting at a cost not to exceed \$25,000.
