#### **MINUTES**

At 7:08 pm, the Special Meeting of the Board of Trustees was called to Order by Village President David Stewart who then led the Pledge of Allegiance. Village Clerk Laurie Gbur recorded the meeting attendance. Present at the meeting were Trustees Debbie Krizel, Mary Pawlak, Jim Schrader, John Schweickert, Trustee Nate Holland and Kylie Mattioda. Also present at the meeting were Village Attorney Herb Klein, Village Engineer Kevin Heitz, and Public Works Director / Zoning Enforcement Officer Curt Spayer. Police Chief Rodney Damron, Director of Village Affairs Jamie Turczyn and Village Treasurer Jill Margis were absent from the meeting.

Village Attorney: Attorney Klein provided a brief summary regarding Petition of Dale Senica, Owner, d/b/a Alley Cat's. The Petitioner is seeking a Special Use under the Village of North Utica Zoning Ordinance Section 10-8B-3, to Operate a Bar with Video Gaming Devices, on property located at 142 Mill St., Utica, IL 61373. The property is Zoned C-1.

Mr. Senica has been making improvements to his building located at 142 Mill St. He is adding approx. 15ft. to the back of the building and adding a large garage door with smoke glass panels.

He is also making improvements to the interior of the building and will be installing a copper ceiling, glazed brick and he is going to dig out the basement to be able to utilize the additional space in the future. He would like to install a small bar and a video gaming room as well as an area with a couple of barber chairs. This will be located in the back of the building and the Tattoo & Piercing Shop will remain in the front of the building. There will be a couple of pub tables and space for a small bar and restrooms.

Mr. Senica has been a resident of Utica for the past 57 years and he would like to provide a nice space in the Village, where someone could come in and have a drink or play a video game while they wait to have their hair cut by a local barber.

The Planning Commission unanimously recommend approval of granting a Special Use for the operation of a Bar with Video Gaming Devices on property located at 142 Mill St., Utica, IL 61373, subject to the business d/b/a Alley Cat's being divided by an emergency access door. There should be no access to Alley Cat's from the front of the building through the Tattoo & Piercing Shop.

Trustee Debbie Krizel made a motion to Table the item. Mr. Senica was not able to attend the Special Board Meeting and Trustee Krizel would like to have further discussions with the Board regarding adding liquor licenses in the Village. She suggested that the Board consider a 6-month moratorium on issuing any additional liquor licenses, pending further review of the Village's Comprehensive Plan that was adopted in 2016.

Mayor Stewart reminded the Board that there are upcoming events that have been approved to be held in the Village that will require temporary event liquor licenses.

Trustee Krizel stated that she believes that the Village needs to review the Comprehensive Plan to determine the plan for the future to include more diversity in what the Village has to offer; a moratorium provides an opportunity to review and discuss the direction that the Village wants to go.

Trustee Schrader stated that the Petitioner, Dale Senica, has already gone through the Public Hearing to seek a liquor license from the Village so the Board needs to consider his Petition.

Trustee Schweickert stated that the Village can still review the Liquor Ordinance without putting a moratorium in place.

Trustee Krizel stated that the Village has a number of the same type of businesses and should be looking for businesses that offer more diversity.

Trustee Pawlak stated that the Board could Table the item until the next meeting because Mr. Senica won't be ready to open for a few months.

Trustee Schrader stated that Mr. Senica has already invested in making significant improvements in the building and although he isn't ready to open, he does want to know that he has been approved so that he can continue with his plans.

Trustee Krizel asked the group if the Village wants an additional bar downtown and located in the back alley.

Trustee Schweickert stated that the business that Mr. Senica wants to open is not necessarily a full bar, but rather a place where you can come in and have a couple of drinks and maybe get your haircut.

Trustee Schrader agreed and stated that the improvements that are being made to the property are a great investment. Trustee Schrader added, "It's a neighborhood barbershop that we would be approving; several other businesses haven't survived in that building."

Trustee Krizel stated that the Board needs to determine what type of businesses they want.

Trustee Holland stated it is a great investment in the community when building improvements are being made by a property owner. He added, "if the Village wants to expand in the city block to the north, we need store fronts filled in this block."

Trustee Pawlak stated that since Mr. Senica didn't attend the meeting, the item should be Tabled.

Trustee Krizel again suggested a 6-month moratorium so that the Board could further discuss the Villages' Liquor Ordinance and have time to review the Comprehensive Plan.

Mayor Stewart stated that if the Board wanted to Table the item, it could be listed on the August Board Meeting Agenda for consideration.

Trustee Schrader stated that this Petition has already been put before the Planning Commission and they have already made an advisory vote on the Special Use.

Trustee Krizel reiterated her motion to Table the item until the August 11, 2022 Board Meeting; The motioned was seconded by Trustee Mattioda.

2022 Project List – The department has been working in Senica Manor on some drainage issues. They will be getting back to the items listed on the 2022 Project List once they have completed the drainage project in Senica Manor.

Village Engineer: Engineer Heitz provided a brief update on the ongoing projects in the Village.

IDOT Rt. 178 & Rt. 6 Roundabout Project – The temporary pavement has been constructed and temporary lights have been installed. Finishing work needs to be completed from the Villages' utility relocation work that was done. The contractor will be finishing some 'punch list' items and the seeding and the Village will receive a final invoice for the project and Engineer Heitz will submit for reimbursement.

'Utica' Sign Plaza Project – Engineer Heitz stated that the 'Utica' Sign Plaza is a nice piece of public art and hopefully it will lead to many people stopping and taking some pictures and then walking to some of our businesses. Trustee Krizel asked if the Village purchased the sign; Mayor Stewart stated that there were donations received toward the purchase. A sign listing the donors toward the project will be placed in the Plaza near the 'Utica' sign.

Neighbor's Park Field – The park field work will be completed. This is something that the Village will need to assess each year, and due to drainage in the area, it will be a recurring expense over the years.

2022 MFT Road Project – The Project will be submitted to IDOT and we should go out for bids in August. Village Administrative Building Parking – Engineer Heitz has been working on other projects so this will need further assessment and surveying over the next couple of months, once some of the other projects have been completed.

Senica Manor Drainage project and the Magnuson Park project are both finished.

Johnson St. Drainage – Engineer Heitz hopes to have some bids in the next couple of weeks.

Doehrr / Hitt St. Drainage — The area has been surveyed and the Village may need to obtain some easements before the drainage issues can be addressed in that area.

There were several smaller projects completed; a patch in front of the Bier Garten, a section of curb in Oak Bluff Subdivision and a section of curb near St. Mary's Church.

The rock filter was replaced and the rock that was removed was used to create an access path around the perimeter of the sewer lagoon. Mayor Stewart stated that there will be a few bills coming in for the work that's been completed there but the sewer lagoon and plant look really good.

Mayor Stewart stated that the Village is getting some designs to consider. There is a possibility that the Village will rename the park to incorporate the Renz Family who has donated so much of the playground equipment in that park.
