## General Requirements:

1. Issuance - Notification to utilities. Before a building can be demolished or removed, the owner or agent shall notify all utilities having service connections within the building, such as water, electric, as, sewer and other connections. A permit to demolish or remove a building shall not be issued until a release is obtained from the utilities stating that their respective service connections and appurtenant equipment, such as meters and regulators, have been removed or sealed and plugged in a safe manner. The applicant is responsible for all costs of removal, and or plugging utilities.
2. Demolition Fee. The fee for a permit for the demolition of a building or structure permit shall be $\$ 30.00$. The demolition permit shall only be valid for a period of two (2) months following issuance of the demolition permit. Upon the expiration of two (2) months, then the demolition permit shall expire and be of no force and effect.
3. This Permit applies to all buildings or structures where there are Village and/or public utilities present in the area where the demolition is being done or where the building or structure to be demolished is greater than 150 square feet.
