At 6:00 pm the meeting was called to Order by Village President David Stewart who then led the Pledge of Allegiance. Village Clerk Laurie Gbur was unable to attend the meeting therefore, Director of Village Affairs, Jamie Turczyn recorded the meeting attendance. Present at the meeting were Trustees Jim Schrader, John Schweickert, Nate Holland and Kylie Mattioda. Also present were Village Engineer Kevin Heitz, Public Works Director / Zoning Enforcement Officer Curt Spayer, Police Chief James Mandujano and Village Treasurer Jill Margis. Trustee Debbie Krizel and Village Attorney Herb Klein were absent from the meeting.

It was motioned by Trustee Schrader, seconded by Trustee Schweickert to appoint Director of Village Affairs Jamie Turczyn as Clerk Pro-Tem for the meeting.

Donation: It was motioned by Trustee Schrader, seconded by Trustee Holland to recommend approval of a Donation in the amount of \$1033 to the 'Music on Mill St. Group' toward the expense for providing the insurance for the Music and Entertainment performing on Mill St. for the remainder of the 2023 Outdoor Dining Season. It was noted that the donation was being made for the remainder of the 2023 Season only. The Insurance expense for the Music on Mill St. for the 2024 Season would need to be further discussed among the Music on Mill St. Group.

Water / Sewer Utility Rate Discussion: A brief discussion was held regarding water / sewer rates in the Village as well as the surrounding communities. Through some exploration and review, we have realized that the Village has been expending more money out than the revenue that is coming in with the current assessed water / sewer rates. The Village will review and discuss the water / sewer rates further at the next meeting.

Water Tower Discussion: The Village is going to obtain additional estimates and information before making any decisions. The matter will be further discussed at the next meeting.

Bioaugmentation in the Village Wastewater Treatment System - A bioaugmentation system can inject bacteria into the Wastewater Treatment system in the Loves Lift Station and it will clean the system. HR Green has provided a proposal to install bioaugmentation to improve the system. We would not need to use as many chemicals to treat the system and we would not have to aerate the system. The cost is \$4,000 per month; there is a 60 day trial which cost \$4,000 (Non-refundable deposit) and a \$7,500 mobilization one-time fee. It was motioned by Trustee Schrader, seconded by Trustee Holland to recommend authorizing the Village President to enter into a Contract with HR Green to install Bioaugmentation in the Village of North Utica Wastewater Treatment System. It was noted that since this is a Contract, the Board would need to approve an Ordinance regarding such.
