Mayor Stewart then provided an update on the 2014 John Deere Tractor that the Village purchased for maintenance of the I & M Canal path. The Tractor has an issue with the transmission and is not repairable. Prairie State Tractor in Streator will take the tractor on trade toward the purchase of a new 2023 John Deere Tractor. The trade in value would be \$15,000; the cost for the new 2023 Tractor, including a loader attachment, would be \$121,500. The Village can finance the tractor over 36 months at 0.9 %. The Bush Hog equipment attachment will work with the new tractor so the Village will not have to purchase another one. It was then motioned by Trustee Schweickert, seconded by Trustee Holland to approve the purchase of a 2023 John Deere Tractor, with the trade in of the 2014 John Deere Tractor, at a cost not to exceed \$110,000 and financed over 36 months.

Further Discussion regarding the Painting / Cleaning / Repairs & Maintenance of the North Utica Water Towers – this item was Tabled; Motioned by Trustee Holland, seconded by Trustee Pawlak.

Village Engineer: Engineer Heitz provided a brief update on the ongoing and upcoming projects in the Village. Hitt St. – The Village had to utilize Pohar Excavating to get through the solid rock in order to install the drainage pipe. We will need to seek bids on the concrete and asphalt work to complete the project. Engineer Heitz is working on the survey to prepare the design and bid documents and he is hopeful that the project will be completed this year before the weather turns colder.

Mini Mill St. Shops Project Design – Once the Hitt St. Project Design is completed, Engineer Heitz will begin to modify the concept plans for the Mini Mill St. Shops Design to add as much as possible to be able to utilize all of the Grant Funding.

2023 MFT Road Project – The contractor, Advanced Asphalt, is putting together the final quantities. Once that has been submitted, we can move forward with that final payment for the project.

Village Attorney: Discussion was held about the Village's Raffle License Ordinance. Fees and the number of Licenses permitted for a Progressive Raffle such as the Queen of Hearts, were discussed. It was then motioned by Trustee Schweickert, seconded by Trustee Krizel to approve an Ordinance amending the Raffle License Ordinance, to create a fee in the amount of \$50 per License; to allow for two (2) Progressive Raffles annually by an organization, however only one (1) License will be issued at a time. ORD 2023-26

Village President: Mayor Stewart provided a brief update on the status of the Awarded Grants and Grant Applications.

Rebuild IL Downtowns & Main Streets Grant: Tentatively by the middle of October we should be ready to have an open house to present the preliminary design plans for the Mini Mill St. Shops Project. The target date for the open house would be October 16<sup>th</sup> however, we may need to move it into the following week as we are still working on finishing the plans for repaving and concrete work on the Hitt St. Drainage Project.

Engineer Heitz added, "Public restrooms that would be closer to the downtown area are of interest to the businesses on Mill St. so we may be able to look at a pre-built option for something like that and this could be included in the design plans for that Project as well."

Mayor Stewart agreed and stated, "Restrooms downtown have been something that has been brought up by the businesses for a long time so if there is a chance to include them in this project, now would be the time to do that while everything in that area is being developed for the Mini Shops."

The Board agreed.

Build Illinois Bond Grant - I & M Canal Rewatering Project: We are still waiting to hear something back on the plans that were submitted; we may not hear anything for several months.

LSLI Grant Application – Lead Service Line Inventory: It was motioned by Trustee Schweickert, seconded by Trustee Pawlak to Authorize the Village President to submit an application through NCICG, seeking an LSLI Grant for Lead Service Line Inventory of the Village of North Utica Water / Sewer Infrastructure.
