At 6:00 pm the meeting was called to Order by Village President David Stewart who then led the Pledge of Allegiance. Village Clerk Laurie Gbur recorded the meeting attendance. Present at the meeting were Trustees Nate Holland, Kylie Mattioda, Debbie Krizel, Pete Pawlak and Jim Schrader. Also present were Village Attorney Herb Klein, Village Engineer Kevin Heitz, Public Works Director / Zoning Enforcement Officer Curt Spayer, Director of Village Affairs Jamie Turczyn and Village Treasurer Jill Margis. Trustee John Schweickert and Police Chief James Mandujano were absent from the meeting.

Village Attorney: Attorney Klein provided a brief summary of the Public Hearing that was held earlier in the evening with the Planning Commission regarding the Petition of Legacy Solar, LLC, as Petitioner and Jason Harmon, as Owner. Village Clerk: Clerk Gbur discussed the renewal options for the Employee Health Insurance. The cost for the renewal of the current Blue Cross Blue Shield Health Insurance Plan will be \$5064.00, an increase of approx. 13.86%. The current plan provides employees with a benefit of an in network deductible in the amount of \$1,000 and an in network out of pocket maximum in the amount of \$2,000. Other options in the Marketplace offer a lower monthly premium, however the deductible ranges from \$3,600 - \$7,900 in network and the and out of pocket maximum ranges from \$15,800 to an unlimited amount. Trustee Mattioda stated that although she is in favor of keeping deductibles within a lower range, she would like the Village to determine the timeline of when the employees would need to begin contributing to the premium cost, as the monthly premium is currently being funded by the Village as the employer. The Board briefly discussed that in the future, the maximum amount of the employer contribution to the monthly premium would be deferred by a percentage of the monthly premium being contributed by full time employees participating in employee Health Insurance. The Board agreed that they will further discuss this at a future meeting in 2024, prior to the next renewal of employee Health Insurance. It was then motioned by Trustee Holland, seconded by Trustee Pawlak to approve the December 1, 2023 renewal of the current Blue Cross Blue Shield of Illinois Employee Health Insurance Policy in the amount of \$5,064.00 per month.
