Mayor Stewart welcomed everyone to the Public Community Open House for the Discussion and Review of the proposed Design Plans for the Rebuild Downtown & Main Street Grant. Mayor Stewart then provided an overview of the Mini Mill St. Shop Development Project being developed on Public Property located at the Northwest corner of Mill St. and Church St. in the Village of North Utica, IL 61373. Director Turczyn began the presentation and then reviewed the information regarding the potential revenue from leasing the units to business owners. Engineer Heitz presented the concept plans for the design of the project.

Questions:

- 1. What is the number of parking spaces? There will be 89 spots throughout the area.
- 2. Will there be Security of the area? Public Wi-Fi and cameras will be provided in the area.
- 3. Will there be EV Stations available?

There has been some discussion to include EV Stations near the Village Hall in the future.

- 4. Will electric be included and what will the lease amount cost? The amount of the rent and utilities has not yet been determined.
- 5. How long will the project take after breaking ground? At least two months, maybe longer than that depending on weather and other factors.
- 6. How will the Village review applications to determine who will be offered a unit? There will be a committee selected to review applications.
- 7. Can some of the parking be addressed while still working on the main area of the project? This could be possible however it has not been determined yet.
