#### **MINUTES**

At 6:18 pm the meeting was called to Order by Village President David Stewart who then led the Pledge of Allegiance. Village Clerk Laurie Gbur recorded the meeting attendance. Present at the meeting were Trustees John Schweickert Nate Holland, Kylie Mattioda, Debbie Krizel, Pete Pawlak and Jim Schrader. Also present were Village Attorney Herb Klein, Village Engineer Kevin Heitz, and Police Chief James Mandujano and Director of Village Affairs Jamie Turczyn. Public Works Director / Zoning Enforcement Officer Curt Spayer and Village Treasurer Jill Margis were absent from the meeting.

Village Attorney: Attorney Klein provided a brief summary of the Petition of Warren and Wendy Munson of Warren and Wendy Munson, as Contract Purchasers of property owned by Thomas Burgess, and located at the Southeast corner of Vine St. and East Grove St., Utica IL 61373; The property is Zoned R-2, Two Family Residential District. Attorney Klein stated that Warren and Wendy Munson were planning to purchase a portion of property from Tom Burgess, owner of the Burgess Funeral Home. The proposed property is located adjacent to Vine St. and Grove St. and is across the street from the Munson's home. The Petitioners are seeking approval of the subdivision of the property, an amendment to the Village of North Utica Zoning Ordinance to allow as a Special Use, an accessory structure on a lot that is not adjoining a principal use and structure, as well as Variances as follows:

Setbacks = Facing Grove St. 20'

Facing Vine St. 10' Facing South 2 ½' Facing East 20'

Garage doors Two at 14' each

Size of Structure To exceed more than 40% of the lot

Attorney Klein stated that during the Public Hearing, Mr. Munson shared that he will be using the accessory structure for the storage of his vehicles and tools, and for the possible future storage of an RV or boat. Mr. Munson also stated that in the future he may divide the second-floor area into rental apartments. Mr. Munson also contacted his neighbors to discuss the project and they didn't have any issues with the plans for the property. Attorney Klein also stated that there will be a driveway from Grove St. to access the structure. Engineer Heitz stated that in the future Mr. Munson may construct a driveway from Vine St. however, at this time Mr. Burgess is granting an easement to allow access to the structure.

The Planning Commission was unanimous in their recommendation to approve the subdivision of the property, the amendment to the Village Zoning Ordinance to allow the accessory structure on a lot not adjoining a principal use and structure as a Special Use, and for the Petitioners to be granted a Special Use as well as the aforementioned Variances. Attorney Klein also stated that a Building Permit application will need to be submitted prior to beginning the construction of the structure.

Village President: Mayor Stewart provided an update on the Rebuild Illinois Downtown & Main Streets Grant; Mini Mill St. Shop Development Project & Design Plan.

Boondocks is going to build one of the small buildings and deliver it to the Village so that we can look at it before they build all of them.

Jamie is reviewing the regulations and rules that other communities have for their mini-shops.

We have already decided that applicants will be required to submit a business plan to be considered for a Lease on a unit.

Update on the Build Illinois Bond Grant; I & M Canal Re-watering Project – Mayor Stewart stated that when we submitted our project, we asked for six years for the pilot program however, we received a response and they would like it to be approved for only a three-year pilot program. We are going to respond to them, once again requesting the six years. We feel that we need six years to effectively study the project.

Cadott Sign system – Mayor Stewart spoke about the proposed purchase of a new sign that would be installed on the North East corner of the Village Hall property near the Heritage Corridor. Trustee Mattioda received some information on this type of sign system several months ago. Jamie and Kylie have reviewed the information to determine what the Village needs as well as the best location for the sign and reached back out to the company to get an updated quote. The sign would be 144" X 96" and the cost would be \$6,000 for the sign and \$1,000 for the panels and approx. \$1,000 for shipping. The sign will be constructed with twenty interchangeable panels for businesses to have their name, an arrow to guide people to their location and in some cases, depending on the length of the businesses' name, even the logo might be able to be included on the panel. The Village would purchase the sign and have it installed and the businesses could apply to have their name on a panel for a fee. The Board agreed that the sign and the proposed location is a great idea to be able to provide visitors with information that can lead them in the direction of businesses located throughout the Village.
