MINUTES

At 6:05 pm the meeting was called to Order by Village President David Stewart who then led the Pledge of Allegiance. Village Clerk Laurie Gbur recorded the meeting attendance. Present at the meeting were Trustees Nate Holland, Trustee Kylie Mattioda, Debbie Krizel and Jim Schrader. Also present were, Director of Village Affairs Jamie Turczyn, and Village Engineer Kevin Heitz. Public Works Director / Zoning Enforcement Officer Curt Spayer, Village Attorney Herb Klein, Village Treasurer Jill Margis and Trustees John Schweickert and Pete Pawlak were absent from the meeting.

Village Clerk: Clerk Gbur provided an update on the approaching end of the seven (7) year Contract with Republic Services for providing Waste Removal Services in the Village. Republic has proposed a five (5) year Contract to continue providing such services in the Village. They are also adding a provision to extend the Contract by an additional three (3) years at the end of the original term. The new Contract would begin on July 1, 2024 and the rates would be increased each year by approx. 5%. We have requested to keep the waste removal services on Monday each week and they do not foresee this day changing however, they are adding language so that in the event that the Village is notified that the day of service would change, we would have the ability to leave the Contract early. The matter will be further discussed at the May meeting.

Village Engineer: Engineer Heitz provided a brief update on the ongoing projects in the Village.

IV Fence & Pool is working on replacing the railing at the Well House and they are working on replacing the fence along Hitt St.

Engineer Heitz stated that he is working on finalizing the fine details of the Mini Mill St. Shops Development Project including the details on parking. Parking will be moved around during the project. We are planning for approx. 108 parking spaces. The Village will be adding more parking spaces on Mill St. across from the Post Office as well as in front of the Library. We will tentatively be ready to seek bids on the project on May 9, 2024 with the bids being due the following week on May 16th. We will probably schedule a Special Board Meeting to review the bids and award a Contract so that we can get the project started.
